#### GSGV Lodge Mobilizes to Help WWII Chinese American Veterans Congressional Gold Medal Campaign

Because of the unrelenting efforts by the National Lodge, and local lodges like GSGV, OC, Washington DC and Boston, as of April 9, there are 38 Senate co-sponsors of S. 1050 and 68 House co-sponsors of H.R. 2358, both bills being introduced in May, 2017. In order to aim for passing the bills without a floor vote, we will need 67 Senate sponsors and 290 House sponsors, respectively, before the end of 2018. It is clear that we are a long way from achieving that goal.

Of the two Senators from California, Dianne Feinstein was already a cosponsor of S. 1050. Our Lodge has mobilized its members to individually send letters to Sen. Kamala Harris for her support and co-sponsorship. On the House side, California has, as of April 9, 17 representatives (out of 53 total) who have signed on to H.R. 2358. Our Lodge's contribution will be to write letters to the non-sponsoring representatives urging them to support the House Bill. Members are also encouraged to seek out friends and relatives who are constituents in districts whose representatives have yet to sign on to H.R. 2358, and ask them to send letters to these representatives. You will be asked to verify the e-petition in your e-mail once the submission is made—that's all you have to do!

### **Brother Charles Attends Community Cannabis Informational Workshop, April 12**

State Assemblyman Ed Chau organized an informational workshop on Cannabis (Marijuana) on April 12 at the East Los Angeles College campus. Brother Charles attended this workshop to gather information on the process of legalization of cannabis retailing at the county level as it is of grave concern to parents of school-age children, including Chinese American parents. Representatives from the County Office of Cannabis Management and the City of Monterey Park were present to give talks. The City has already passed resolutions prohibiting the retail of cannabis within city limits. However, residents are allowed to grow six cannabis plants within their properties, and all consumption of marijuana is limited to indoors. Chinese owners of rental properties are reminded to write into their lease agreements prohibiting tenants to grow cannabis plants and consume marijuana inside the premise, if they so desire.

Our next Lodge meeting will be held on May 7, the FIRST MONDAY of the month. This is a one-time change.
